**WHAT TO BRING**

- Photo ID (driver's license, passport, etc.)
- Social Security cards for ALL people on your return (yourself, spouse, all dependents)
- If you don't have Social Security numbers, Tax Identification Number(s) for ALL people on return (yourself, spouse, all dependents)
- Original W-2s, 1099s, 1098s, and all other year-end tax forms you have received
- Documentation of any social security, unemployment, gambling, interest or dividend income
- If claiming child care expenses: name, address and tax ID number of the provider
- If a non-custodial parent claiming a child: Form 8332 (for a 2009 divorce decree) or a copy of a pre-2009 divorce decree
- Homeowners: proof of payment of real estate taxes
- New vehicle purchasers (made after 2/16/09): receipt showing sales tax paid
- New home purchasers: paperwork showing cost and date of purchase
- Bank routing and account numbers for a fast and safe direct deposit of your refund
- A copy of last year's tax return, if available

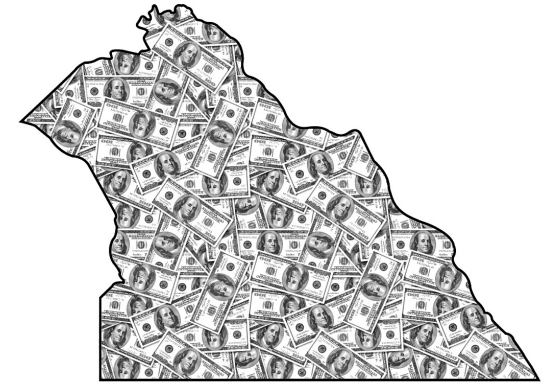
