

# United Way of York County Prize Giveaway Rules

1. Participants must be at least 18 years of age at the time of entry, and possess a valid driver's license or other form of photo identification. All prizes have been donated by local companies. Entry forms must be returned to the United Way office at 800 E. King St., York, PA 17403, by noon on Friday, November 19, 2021. Prize winners will be announced at the Campaign Celebration to be held in early 2022. Winner (or their representative) must be present at Celebration. No contribution to the United Way of York County is required to submit an entry form into the prize drawing. Participants may enter only one (1) entry form per person.
