Early Childhood Education: For The Next Generation

- Early Childhood Education Scholarships funds ALICE families enrolled in centers across York County, helping parents work while children receive quality care.
- Early Childhood Education Grants tuition alone does not cover the cost, and these dollars support high-quality, affordable childcare centers.
- Proud ECHO (Every Child Has Opportunities) Supporter a coalition of funders and providers supporting new early childhood education startups and existing programs.

Transportation: To Connect Our Community

- Ride United Grants provide ALICE households with transportation support to safely get to and from work.
- Transportation Innovation Grants will fund transformative solutions for ALICE households in York County.

Financial Wellness: Because Every Dollar Counts

- VITA (Volunteer Income Tax Assistance Program) a free tax preparation program for low to moderate-income York County residents. Last tax season, we put more than \$2.7 million back into our local economy.
- United for Financial Fitness, we offer free budgeting and credit seminars to help ALICE maximize their income.
